NOTICE OF RACE

The Organising Authority is the NSW & ACT District Laser Association in association with Lane Cove 12' Sailing Skiff Club

1. RULES

The Championship will be governed by the Racing Rules of Sailing, and the Prescriptions and Special Regulations of Yachting Australia.

2. ELIGIBILITY

All competitors shall be financial members of a District of the ILCA and of a Yacht or Sailing Club affiliated with a National Authority. Eligibility for age groups shall be the age on 8th March 2014.

3. ENTRIES

3.1 Entries on the attached entry form, or on-line at www.laser.asn.au, together with the entry fee should reach the Regatta Secretary by 8th March 2014.

3.2 Beach entries may be accepted up until 1130 hours Saturday 8th March 2014.

4. FEES

Entry fee schedule:

- \$60.00 per boat for sailors aged over 21
- \$30.00 per boat for sailors aged under 21

5. SCHEDULE

5.1 Championship Schedule:

Sat	8 Mar	Racing	First Warning Signal 1330 hrs. Subsequent starts shall be made ASAP after the preceding race
Sun	9 Mar	Racing	First Warning Signal 1100 hrs. Subsequent starts shall be made ASAP after the preceding race

5.2 A maximum of six races are scheduled for the Championship.

5.3 No Warning Signal shall be hoisted after 1530 hrs on the Sunday 9th March 2014.

6. MEASUREMENT

Each skipper shall be responsible for ensuring that their yacht and equipment comply with the ILCA rules and the Yachting Australia Special Regulations. The Organising Authority reserves the right to inspect any yacht at any time during the Regatta.

7. SAILING INSTRUCTIONS

The Sailing Instructions should be available on the NSW and ACT Laser Association website www.laser.asn.au and will be available at registration.

8. REGATTA VENUE

The Regatta venue is shown in Illustration A. Lane Cove 12' Sailing Skiff Club is located at Longueville Wharf, Stuart Street, Longueville NSW www.lc12ftssc.org.au. It is the Race Committee's intention to establish a separate beach at Hunters Hill Sailing Club, Merrington Place, Woolwich NSW www.huntershillsailingclub.org.au

9. RACING AREA

The racing area is shown in Illustration B.

10. CATEGORIES AND DIVISIONS

10.1 Categories are as described in the Entry Form.

10.2 There will be a separate start for each of Standard, Radial and 4.7 Divisions, providing there is a minimum of eight entries to the Division. Division starts may be further split depending on the number of competitors.

11. COURSES

The courses shall be inner and outer loop trapezoids as described in the Sailing Instructions.

12. SCORING

Six races are scheduled, of which three shall be completed to constitute a series. When four or more races are completed, the worst will be discarded. All Divisions will be scored separately.

13. PRIZES

Prizes will be awarded to the winners of each Division. Other prizes may also be awarded at the discretion of the Organising Authority.

14. INSURANCE

Each participating boat shall be insured with a valid third party liability insurance with cover of not less than \$AUS 10,000,000.

15. DISCLAIMER

All those taking part in this Regatta do so at their own risk and responsibility. Attention is drawn to Fundamental Rule 4 Decision to Race "A boat is solely responsible for deciding whether or not to start or to continue racing". The NSW and ACT District Laser Association, Lane Cove 12' Sailing Skiff Club, their officers, and the Regatta officials, volunteers and sponsors do not accept any liability for the material damage or personal injury or death sustained in conjunction with or prior, during or after the regatta. The Organising Authority reserves the right to refuse an entry.

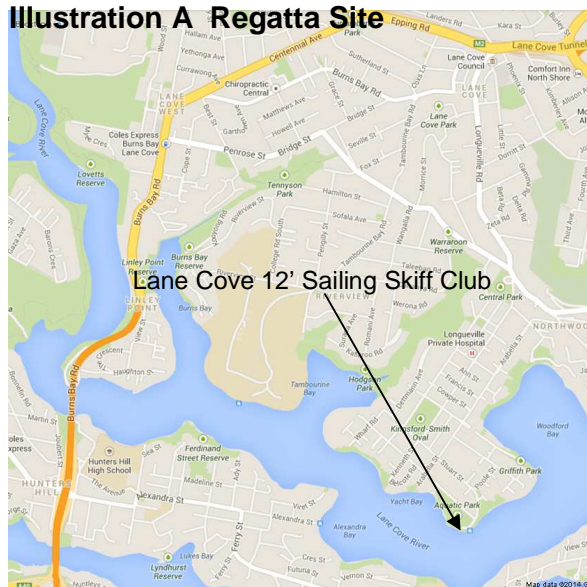
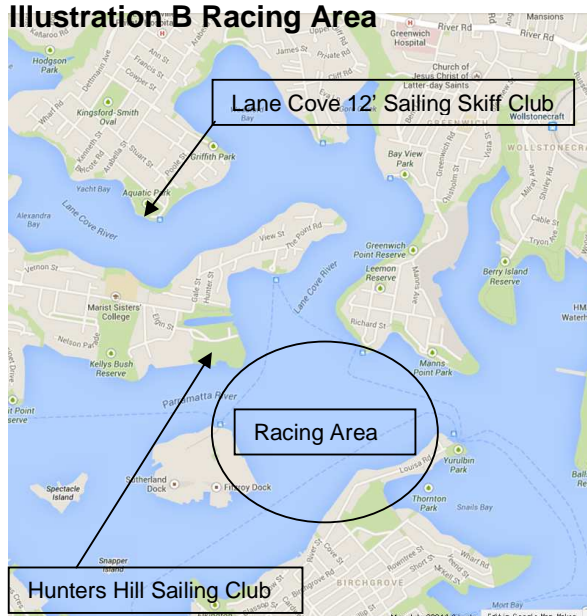


Illustration B Racing Area
