NOTICE OF RACE

The Organising Authority is the Hunters Hill Sailing Club in association with ILCA NSW & ACT $\,$

1. <u>RULES</u>

The Championship will be governed by the Racing Rules of Sailing, and the Prescriptions and Special Regulations of Australian Sailing.

2. <u>ELIGIBILITY</u>

All competitors shall be financial members of a District of the ILCA and of a Yacht or Sailing Club affiliated with a National Authority. Eligibility for youth age groups shall be the age on 31 December 2025. Eligibility for all other age groups shall be the age on 8th March 2025

3. ENTRIES

- 3.1 Entries on the attached entry form, or on-line at <u>www.laser.asn.au</u>, together with the entry fee should reach the Regatta Secretary by 8th March 2025.
- 3.2 Beach entries may be accepted up until 1130 hours Saturday 8th March 2025.

4. **FEES**

Entry fee schedule:

- \$100.00 per boat for sailors aged over 21
- \$50.00 per boat for sailors aged under 21

5. <u>SCHEDULE</u>

- 5.1 A maximum of six races are scheduled for the Championship.
- 5.2 No Warning Signal shall be made after 1530 hrs on the Sunday 9th March 2025.

5.3 Championship Schedule:

Sun	9 Mar	Racing	First Warning Signal 1100 hrs. Subsequent starts shall be made ASAP after the preceding race

6. MEASUREMENT

Each skipper shall be responsible for ensuring that their yacht and equipment comply with the ILCA rules and the Yachting Australia Special Regulations. The Organising Authority reserves the right to inspect any yacht at any time during the Regatta.

7. SAILING INSTRUCTIONS

Will be available on the regatta website <u>www.laser.asn.au/</u> and may be available at registration.

8. <u>REGATTA VENUE</u>

9. RACING AREA

The racing area will be the waters of Parramatta River in the vicinity of HHSC.

10. CLASSES AND DIVISIONS

- 10.1 Classes and Divisions are as described in the Entry Form.
- 10.2 There will be a separate start for each of ILCA 7, ILCA 6 & ILCA 4 Classes, providing there is a

minimum of eight entries to the Class. Class starts may be further split depending on the number of competitors.

11. COURSES

The courses shall be described in the Sailing Instructions.

12. <u>SCORING</u>

Six races are scheduled, of which three shall be completed to constitute a series. When four or more races are completed, the worst will be discarded. All Division prizes will be awarded based on the ranking of competitors in the overall results of the applicable Class.

13. <u>PRIZES</u>

Prizes will be awarded to the winners of each Division. Other prizes may also be awarded at the discretion of the Organising Authority.

14. INSURANCE

Each participating boat shall be insured with a valid third party liability insurance with cover of not less than \$AUS 10,000,000.

15. DISCLAIMER AND RISK WARNING

All those taking part in this Regatta do so at their own risk and responsibility. By entering competitors acknowledge the following ILCA NSW and ACT Inc. Risk Warning.
