NOTICE OF RACE

Organising Authority is ILCA NSW & ACT Inc.in association with South Lake Macquarie Amateur Sailing Club SLMASC

1. RULES

The Championship will be governed by the Racing Rules of Sailing, and the Prescriptions and Special Regulations of Australian Sailing.

2. ELIGIBILITY

All competitors shall be financial members of a District of the ILCA and of a Yacht or Sailing Club affiliated with a National Authority. Eligibility shall be the age on 1st February 2025.

3. ENTRIES

- 3.1 Entries can be made on-line at www.laser.asn.au, or at the event.
- 4. Entry is not refundablet.
- 4.1 Entries will be accepted up until 1130 hours Saturday 1st February 2025
- 5. **FEES**

Entry fee is \$120.00 per boat

6. CATEGORIES AND DIVISIONS

- 5.1 Categories are as described in the Entry Form.
- 5.2 There will be a separate start for each of ILCA 7, ILCA 6 and ILCA 4 Divisions, providing there is a minimum of five entries to the Division. Division starts may be further split depending on the number of competitors.

7. SCHEDULE

7.1 The Championship Schedule is:

Sat	1 Feb	Racing	First Warning Signal 1330 hrs. Subsequent starts shall be made ASAP after the preceding race
Sun	2 Feb	Racing	First Warning Signal 1200 hrs. Subsequent starts shall be made ASAP after the preceding race

- 5.2 A maximum of six races are scheduled for the Championship.
- 5.3 No Warning Signal shall be made after 1630 hrs on the Sunday 2nd February 2025.

8. MEASUREMENT

Each skipper shall be responsible for ensuring that their yacht and equipment comply with the ILCA rules and the Australian Sailing Special Regulations. The Organising Authority reserves the right to inspect any yacht at any time during the Regatta.

9. **SAILING INSTRUCTIONS**

The Sailing Instructions will be available on the ILCA NSW and ACT website http://www.laser.asn.au/ and may be available at registration.

10. REGATTA SITE

The Championship venue is shown in Illustration A. South Lake Macquarie Amateur Sailing Club is located at

11. RACING AREA

The racing area will be the waters of Lake Macquarie adjacent to SLMASC.

12. <u>COURSES</u>

The courses shall be inner and outer loop trapezoids as will be described in the Sailing Instructions.

13. SCORING

- 5.3 Six races are scheduled, of which three shall be completed to constitute a series. When four or more races are completed, the worst will be discarded.
- 5.4 Divisions will be scored as part of their fleet (ILCA 7, ILCA 6 and ILCA 4).

14. PRIZES

Prizes will be awarded to the winners of each Division. Other prizes may also be awarded at the discretion of the Organising Authority.

15. INSURANCE

Each participating boat shall be insured with a valid third party liability insurance with cover of not less than \$AUS 10,000,000.

16. <u>DISCLAIMER</u>

All those taking part in this Regatta do so at their own risk and responsibility.

Attention is drawn to Fundamental Rule 3 Decision to Race "A boat is solely responsible for deciding whether or not to start or to continue racing".

ILCA NSW and ACT Inc., South Lake Macquarie ASC, their officers, and the regatta officials, volunteers and sponsors do not accept any liability for the material damage or personal injury or death sustained in conjunction with or prior, during or after the regatta.

The Organising Authority reserves the right to refuse an entry.


