# ***NOTICE OF RACE***

The Organising Authority is the Speers Point Amateur Sailing Club in association with the ILCA NSW & ACT Inc.

## **1. RULES**

The Championship will be governed by the Racing Rules of Sailing, and the Prescriptions and Special Regulations of Australian Sailing.

## **2. ELIGIBILITY**

All competitors shall be financial members of a District of the ILCA and of a Yacht or Sailing Club affiliated with a National Authority. Eligibility for youth age groups shall be the age on 31st December 2027. Eligibility for all other age groups shall be the age on 17<sup>th</sup> October 2026.

## **3. ENTRIES**

- 3.1 Entries on the attached entry form, or on-line at [www.laser.asn.au](http://www.laser.asn.au), together with the entry fee should reach the Regatta Secretary by 17<sup>th</sup> October 2026.
- 3.2 Beach entries may be accepted up until 1130 hours Saturday 17<sup>th</sup> October 2026.

## **4. FEES**

Entry fee schedule:

- \$100.00 per boat for sailors aged over 21
- \$50.00 per boat for sailors aged under 21

## **5. SCHEDULE**

- 5.1 A maximum of six races are scheduled for the Championship.
- 5.2 No Warning Signal shall be made after 1600 hrs on the Sunday 18<sup>th</sup> October 2026.
- 5.3 **Championship Schedule:**

| Sat | 17 Oct | Racing       | First Warning Signal 1330 hrs. Subsequent starts shall be made ASAP after the preceding race |
| Sun | 18 Oct | Racing       | First Warning Signal 1100 hrs. Subsequent starts shall be made ASAP after the preceding race |

## **6. MEASUREMENT**

Each skipper shall be responsible for ensuring that their yacht and equipment comply with the ILCA rules and the Yachting Australia Special Regulations. The Organising Authority reserves the right to inspect any yacht at any time during the Regatta.

## **7. SAILING INSTRUCTIONS**

Will be available on the regatta website [www.laser.asn.au](http://www.laser.asn.au) and at registration.

## **8. REGATTA VENUE**

The Regatta venue is shown in Illustration A. Speers Point Amateur Sailing Club (<https://www.spasc.org.au/>) is located at 20B Park Road, Speers Point NSW 2284.

## **9. RACING AREA**

The racing area will be on Northern end of Lake Macquarie.

## **10. CLASSES AND DIVISIONS**

- 10.1 Classes and Divisions are as described in the Entry Form.
- 10.2 There will be a separate start for each of ILCA 7, ILCA 6 and ILCA 4 Classes, providing there is a minimum of eight entries to the Class. Class starts may be further split depending on the number of competitors.

## **11. COURSES**

The courses shall be inner and outer loop trapezoids as described in the Sailing Instructions.

## **12. SCORING**

Six races are scheduled, of which three shall be completed to constitute a series. When four or more races are completed, the worst will be discarded. All Division prizes will be awarded based on the ranking of competitors in the overall results of the applicable Class.

## **13. PRIZES**

Prizes will be awarded to the winners of each Division. Other prizes may also be awarded at the discretion of the Organising Authority.

## **14. INSURANCE**

Each participating boat shall be insured with a valid third party liability insurance with cover of not less than \$AUS 10,000,000.

## **15. DISCLAIMER AND RISK WARNING**

All those taking part in this Regatta do so at their own risk and responsibility.

Attention is drawn to Fundamental Rule 4 Decision to Race "A boat is solely responsible for deciding whether or not to start or to continue racing".

ILCA NSW & ACT Inc. Speers Point Amateur Sailing Club, their officers, and the regatta officials, volunteers and sponsors do not accept any liability for the material damage or personal injury or death sustained in conjunction with or prior, during or after the regatta.

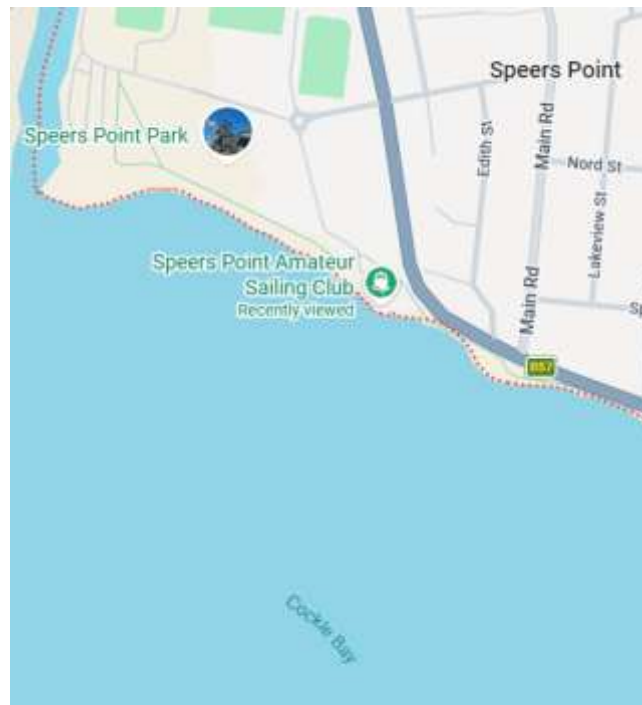
