NOTICE OF RACE

The Organising Authority is Georges River Sailing Club in association with the ILCA NSW & ACT Inc.

1. <u>RULES</u>

The Championship will be governed by the Racing Rules of Sailing, and the Prescriptions and Special Regulations of Australian Sailing.

2. **ELIGIBILITY**

All competitors shall be financial members of a District of the ILCA and of a Yacht or Sailing Club affiliated with a National Authority. Eligibility for youth age groups shall be the age on 31st December 2025. Eligibility for all other age groups shall be the age on 16th November 2024.

3. ENTRIES

- 3.1 Entries can be made on-line at www.laser.asn.au, or at the event.
- 3.2 Entry is not refundable.
- 3.3 Entries will be accepted up until 1130 hours Saturday 16th November 2024.

4. **FEES**

Entry fee schedule:

- \$100.00 per boat for sailors aged over 21
- \$50.00 per boat for sailors aged under 21

5. SCHEDULE

- 5.1 A maximum of six races are scheduled for the Championship.
- 5.2 No Warning Signal shall be made after 1530 hrs on the Sunday 17th November 2024.

5.3 Regatta Schedule:

Sat	16 Nov	Racing	First Warning Signal 1330 hrs. Subsequent starts shall be made ASAP after the preceding race
Sun	17 Nov	Racing	First Warning Signal 1100 hrs. Subsequent starts shall be made ASAP after the preceding race

6. <u>MEASUREMENT</u>

Each skipper shall be responsible for ensuring that their yacht and equipment comply with the ILCA rules and the Yachting Australia Special Regulations. The Organising Authority reserves the right to inspect any yacht at any time during the Regatta.

7. SAILING INSTRUCTIONS

Will be available on the regatta website www.laser.asn.au/ and will be available at registration.

8. REGATTA VENUE

RACING AREA

The racing area will be on Botany Bay.

9. <u>CLASSES AND DIVISIONS</u>

- 10.1 Classes and Divisions are as described in the Entry Form.
- 10.2 There will be a separate start for each of ILCA 7, ILCA 6 & ILCA 4 Classes. Class starts may be further split depending on the number of competitors.

10. COURSES

The courses shall be inner and outer loop trapezoids as described in the Sailing Instructions.

11. SCORING

Six races are scheduled, of which three shall be completed to constitute a series. When four or more races are completed, the worst will be discarded. All Division results will be based on the ranking of competitors in the overall results.

PRIZES

Cubes will be awarded for both the State Open and State Masters regattas in accordance with the ILCA By-Laws. Other prizes may also be awarded at the discretion of the Organising Authority.

12. INSURANCE

Each participating boat shall be insured with a valid third party liability insurance with cover of not less than \$AUS 10,000,000.

13. DISCLAIMER AND RISK WARNING

All those taking part in this Regatta do so at their own risk and responsibility.

Attention is drawn to Fundamental Rule 3 Decision to Race "A boat is solely responsible for deciding whether or not to start or to continue racing".


